Non-Franchise	Short- and long- term activities in the right-of-way and on private property. This includes sewer, water, storm drainage, utility installation and repair, grading, paving, painting/ striping, frontage/ street improvements, curb cuts, driveways, sidewalks, fences, landscaping, trenching, boring, and culverts.	<ol style="list-style-type: none"> 1. Franchise	Short and long-term activities in the right-of-way, similar to the non-franchise subtype defined above, except that applicant holds a franchise agreement with the City. This includes telecommunications, utilities for connections, repairs, and pulling cable through existing conduit.	<ol style="list-style-type: none"> 1. Site Plan 2. Small Wireless	Activities in the right-of-way pertaining to small wireless facilities with applicants who hold a franchise agreement with the City. Annual Blanket Activities	Issued to franchise holders on an annual basis to undertake blanket activities that does not include cutting, removing or disturbing the pavement surface. This includes simple service disconnects, repair or replacement of existing equipment on poles, access and maintenance of vaults, vegetation management, flushing activities, and all activities listed under TMC 11.08.020.	1. Insurance (TMC 11.08.150)

Unless the Director determines that there is not a probability of injury, damage, or expense to the City arising from an applicant's proposed use of the right-of-way or public place, or the applicant holds a current franchise with the City, the applicant shall obtain and maintain in full force and effect, throughout the term of the permit, or as long as the permittee has facilities in the right-of-way, an insurance policy issued by an insurance company satisfactory to the Director, insuring both the applicant and the City against claims for injuries to persons, death or damages to property that may arise from, or in connection with, the exercise of the rights, privileges and authority granted to the applicant under this chapter.

Deposits, Fees and Bonds (TMC 11.08.160)

Before a permit pursuant to the provisions of this chapter may be issued, the applicant may be required, unless otherwise provided in a current franchise, to execute to the City a financial guarantee in a form as approved by the City for the proper protection of the City and conditioned that obligors of the financial guarantee will pay to the City the costs and expenses incurred by the City should the person obtaining the permit fail, neglect or refuse to properly complete the work authorized by the permit within the time limit specified by said permit.
